 - (11) We understand that we are not required by any law to sign this authority but it may be required by Easy One, for example, to facilitate margin lending to us or to allow our securities or securities collateral to be lent to or deposited as collateral with third parties. We also understand that if we sign this authority and our securities or securities collateral are lent to or deposited with third parties, Easy One shall remain responsible to us for securities or securities collateral lent or deposited under our authority, a default by Easy One could result in the loss of our securities or securities collateral.
